- 1. The risk of handling firearms and being near others that have firearms in their possession;
- 2. The risk of injury from ammunition and shot from other guns;
- 3. Walking in rugged country, including encounters with wildlife, animals and insects;
- 4. Inclement weather conditions:
- 5. The risk of injury from the use of tree stands.

I understand the risks, hazards, and dangers of hunting and have had the opportunity to discuss them with **Alaska Private Guide Service**. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.
